## Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

### PLEASE READ CAREFULLY

Locust Hill Baptist Church cannot guarantee as a result of participation in the recreation programs that you or your child(ren) will not become infected with COVID-19. Further, participating in Locust Hill Baptist Church recreation activities could increase your risk and your child(ren)'s risk of contracting COVID-19. Additionally, the undersigned acknowledges and agrees that due to the nature of the facilities, services and programs offered by Locust Hill Baptist Church, social distancing of six (6) feet per person among children and between children and their coaches in a recreation setting is not possible.

The undersigned hereby agrees, represents, and warrants that neither the undersigned nor such participating child(ren) shall participate in the recreation programs of Locust Hill Baptist Church if he/she/they:

- (i) experience(s) symptoms of COVID-19, including without limitation, fever, cough or shortness of breath, or
- (ii) has a suspected or diagnosed/confirmed case of COVID-19.

The undersigned agrees to notify Locust Hill Baptist Church immediately if he or she believes that any of the foregoing access/use restrictions may apply.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and knowingly and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending a Locust Hill Baptist Church recreation program and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at a Locust Hill Baptist Church program may result from actions, omissions, or negligence of myself and others, including, but not limited to, Locust Hill Baptist Church employees, ministry leaders, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance or participation in Locust Hill Baptist Church recreation programming ("Claims").

IN CONSIDERATION OF PERMITTING MY CHILD(REN) TO PARTICIPATE IN A LOCUST HILL BAPTIST CHURCH RECREATION PROGRAM, on my behalf and on behalf of my heirs, and on behalf of my child(ren) and on behalf of his/her/their heirs, I HEREBY RELEASE, COVENANT NOT TO SUE, DISCHARGE, AND HOLD HARMLESS LOCUST HILL BAPTIST CHURCH, its employees, ministry leaders, agents and the representatives, of and from the Claims WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH or loss or damage to

person or property, including all liabilities, claims, actions, damages, costs or expenses of any kind (including attorney's fees) arising out of and related thereto. I understand and agree that this release includes any claims based on actions, omissions, or negligence of the Locust Hill Baptist Church, its employees, ministry leaders, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Locust Hill Baptist Church recreation program.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTANDING ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS AND SUBSTANTIAL RIGHTS OF MY CHILD(REN) BY SIGNING IT AND SIGN IT FREELY AND VOLUNTARILY ON MY BEHALF AND ON BEHALF OF MY CHILD(REN) WITHOUT ANY INDUCEMENT.
